- Confirm real world performance and reliability with a "demo" e-bus (pictured)
- Planning for adequate charging infrastructure to support eventual buses
 - Ongoing: Preliminary design and engineering for 161 Lincoln Rd (the Garage)
 - Next Steps: Formal permitting process with Town & Eversource
- Apply for all eligible State grants to mitigate federal EPA uncertainty
 - Awaiting results for MassDEP DERA Program and the MassCEC "V2X" Program
 - Evaluating the new MassCEC School Bus Deployment program (next page)







No additional commitments or cost to Lincoln Public Schools






Doherty's is requesting a Letter of Commitment to apply for this flexible State funding source.

Key details include:

- The grant will provide up to \$2.5M for applicants to electrify a "significant portion of their existing fleet"
 - Funds can be used for buses and charging infrastructure
 - Award can be combined with Federal EPA funds if they materialize
 - Middlesex County applications will have preference for poor air quality
 - Recommend applying for between 4 and 6 buses
- Doherty's, as the applicant, is wholly responsible for all costs and grant reporting
 - No additional commitments or costs to Lincoln Public Schools; all provisions are included in Amendment 1 of our contract
 - The application requires a "site plan". Doherty's is currently planning to submit existing materials for the Garage at 161 Lincoln Rd
 - Applications due June 13th with awards expected June 30th


