The finances for the Lincoln Public Schools ended FY22 with a budget surplus, with all obligations met. Details of the status of the FY22 budgets for both campuses follow. The report also provides for the prior year encumbrance balances and activity.

Lincoln Campus For the past several years, the School Committee has been able to accomplish some strategic purchasing at the end of the fiscal year.

At the end of FY22, when the Town Finance Director closed the books, the Lincoln appropriated budget returned the following amounts:

Significant this year, the MEDICAID reimbursement generated \$82,829.24 that will be applied to the Lincoln Budget for FY 24. This is an increase from \$14,300 applied to FY23.

Hanscom Campus Any balances remaining in the Hanscom allocated budget were to be returned to the Hanscom Reserve Account.

At the end of FY22, when the Town Accountant closed the books, the Hanscom allocated budget returned the following amounts:
