Description: This grant application proposes an interdisciplinary conference, "Science of Emotion," aimed at equipping educators with evidence-based strategies to support students facing emotional and mental health challenges.

Background: The need for this project stems from last year's incidents of emotional dysregulation and bullying, which raised concerns among students, staff, and families about creating a safer, calmer environment. While Lincoln experiences fewer challenges compared to other middle schools, the focus on supporting all students and staff is paramount. This conference will connect with the current curriculum by promoting innovative teaching practices and authentic learning experiences that foster critical thinking, collaboration, and cultural understanding, ultimately advancing equity and engagement. It aims to enhance the existing efforts and inspire new strategies to meet educational goals.

Goals and objectives: The goals are to gather diverse resources that can be shared with the broader staff, enhancing the school and district's commitment to student support. The best outcome would be for the attending team to lead professional development sessions and share insights in team meetings, creating a ripple effect throughout the school that improves student behavior, emotional regulation, and trauma-informed classroom management.

Project Summary (1-3 sentences)

Teaching students to be behaved, regulated, and resilient is a challenge when students come to school with explosive emotions, stress, trauma, emotional dysregulation, and mental health issues. A 2023 ReThinkFirst "Mental Health in the Classroom" Survey found that 43% of parents said their children are highly or extremely stressed, 36% of parents are worried about bullying, 75% of parents observed one or more symptoms of poor mental health in their child, and 61% say their kids need skills that will teach them how to recognize and understand their emotions. A 2024 Pew Research Center Survey found 49% of teachers say behavior for most students is just fair or poor; 68% say they've experienced verbal abuse by students, and 40% say students have been violent towards them. This interdisciplinary conference will explore the "Science of Emotion" and its profound impact on behavior, resilience, regulation, and mental health. We will discover evidence-based strategies to calm challenging behaviors and manage classrooms; promote emotional intelligence and regulation; raise resilience; create a trauma-informed school; encourage empathy; confront bullying; improve reading; and ensure emotionally-engaged classrooms.

What are your goals for this project? What would be the best outcome for the work you propose?

I expect that we will takeaway a variety of strategies and resources that can be shared with the broader staff in supporting our students and classrooms in a variety of ways. One of our school goals and district goals centers around student supports, and this evidence-based conference aims to provide enriching materials and resources from which we can further promote how we support our students with emotional regulation, relationship-building, and more. The best outcome would be that the three of us could lead PD and share ideas in team meetings that will disseminate throughout the school, leading to improved student behavior, emotional regulation, and classroom management that is trauma-informed.

How have your education, training, and or/classroom experiences prompted the interest or need for this project? How does your project promote innovative teaching and authentic learning experiences to foster critical thinking, collaboration, and cultural understanding to advance equity and engagement? Last year, we had a number of emotionally dysregulated student situations and bullying complaints that prompted students, staff, and families to wonder what more can be done to support a safer, calmer school environment. While we tend to enjoy far less, in number and severity, situations than many middle schools, the district and school will still focus on ways we can further our support of staff and students to meet all needs. This national conference brings together the best researchers and practitioners in the fields of psychology, social sciences, and more and are able to provide evidence-based strategies and resources from which we can learn and grow as professionals. I anticipate this conference will enhance the steps we have already taken and will provide new ideas for additional ways we can meet our ultimate goals.  - As a newer building leader, I feel this will give me increased awareness of how I can support my staff in multiple areas beyond what my primary experience has been in terms of curriculum and classroom management.
 - I anticipate this conference will allow us to build out multiple professional development sessions that will not only benefit the Lincoln 5-8 staff and students but could also extend to PK-4 and Hanscom as well.
 - In the short-term, I see us being able to share strategies with staff and students to promote relationship-building, emotional resilience, and calm challenging behaviors.
 - In the long-term, I see a broader approach to how we support students' (and staff's) emotional needs, relationship-building to reduce bullying, and foster positive relationships across grades and the school at large.
 - Those most impacted by trauma and emotional dysregulation would be primary beneficiaries but the entire student body and staff ultimately would benefit.

Evaluation and Sustainability (one paragraph or bullet points)

- a) How will you evaluate the success of the project?
 - We would see a reduction of student counseling requests and increased use of self-regulation strategies in classrooms.
 - We would see a reduction in discipline referrals.
 - We would see staff use more strategies on their own in supporting student regulation and emotional resilience.
 - We would see students self-reporting increased engagement with the school and increased sense of school connectedness and safety.

b) How do you anticipate this project will enhance learning after its funding is complete? Is this project something that can be incorporated in future years without additional support? If successful, will it spread to other classes/grades and/or schools?

- I anticipate that staff will grow in their understanding and use of strategies for improved classroom management and supporting students' emotional regulation.
- I anticipate students will increase their own understanding of how to emotionally regulate when necessary and how to improve their empathy for one another.
- This is a single conference whose impact could last years without needing to resend staff to future conferences.
- The knowledge learned will most certainly spread across grades and likely schools too.
